# ASCENDER - Approve and Receive Purchase Orders

The purpose of this document is to guide you through the necessary steps to approve and receive purchase orders in Purchasing.

After the [Set up Purchasing Options and Permissions](#), [Manage Purchasing Approval Workflows](#), and [Perform Requisition Maintenance](#) processes are addressed, use the following steps to approve and receive purchase orders in Purchasing.

This document assumes you are familiar with the basic features of the ASCENDER Business system and have reviewed the [ASCENDER Business Overview guide](#).



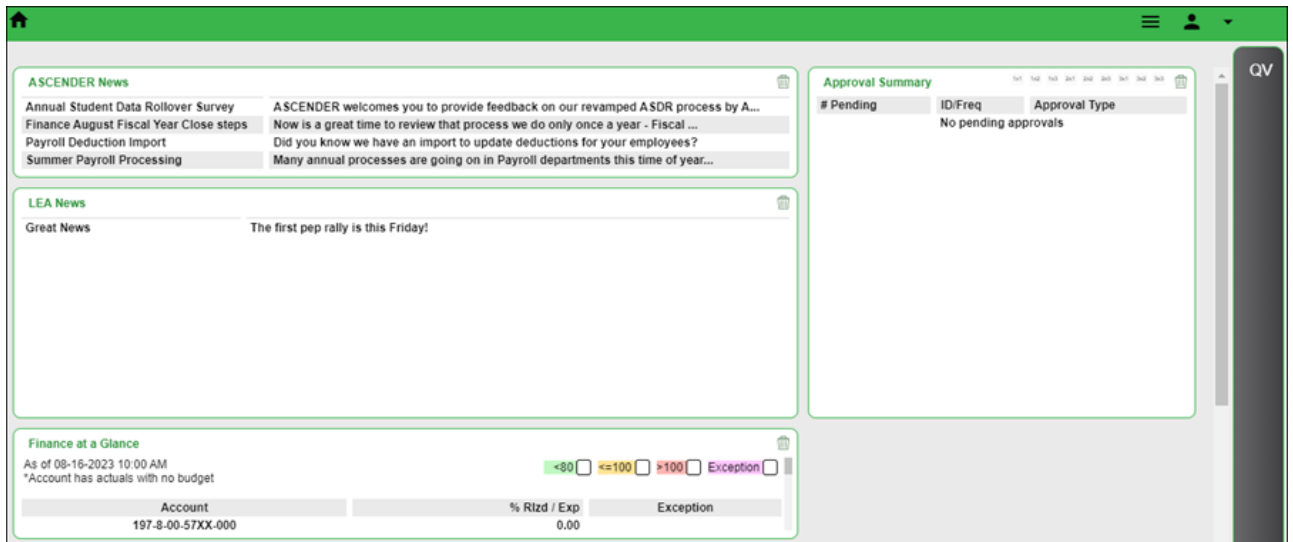

## Dashboard

### 1. [Dashboard](#):

#### **ASCENDER Homepage & Quick View Dashboard**

Depending on your user profile, ASCENDER offers a Quick View dashboard that is used to display important information from multiple sources in one, easy-to-access place. Currently, the following dashboard elements are available for Business users:



- **ASCENDER News** - (All users) Displays important announcements or upcoming events. The ASCENDER News is managed by the Texas Computer Cooperative (TCC).
  - Each news entry displays a topic and a description. An ellipsis (...) is displayed at the end of the description indicating that additional details are associated with the entry.
  - You can click anywhere on the news entry to open the corresponding pop-up window, which displays the full contents of the news entry. Click **Close** or  to close the pop-up window.
  - If there are no news entries to display, a message is displayed prompting you to stay tuned for upcoming news.
- **LEA News** - (All users) Displays important announcements or upcoming events directly from the LEA. The LEA News is managed by the local education agency (LEA) in District Administration.
  - Each news entry displays a topic and a description. An ellipsis (...) is displayed at the end of the description indicating that additional details are associated with the entry.
  - You can click anywhere on the news entry to open the corresponding pop-up window, which displays the full contents of the news entry. Click **Close** or  to close the pop-up window.
  - If there are no news entries to display for the current date range or if you do not have permission to the application or breadcrumb (menu item) associated with the entry, the following message is displayed: "No news is good news".
- **Finance at a Glance** - (Business users with permission to Finance, Purchasing, or Warehouse) Displays a personalized summary of accounts based on your user profile in District Administration. The Finance at a Glance will display a percentage of received/spent monies based on your user profile. This percentage can be filtered for expenditures less than 80 percent, between 80 percent and 100 percent, greater than 100 percent, and those accounts that have spent money with no budget. Accounts are summarized by fund/year, function, major object (first 2 digits), and organization. The table displays the **Account**, **% Rlzd / Exp**, and **Exception** columns.

- This data is retrieved from the general ledger balances in Finance file ID C and is sorted by account code.
- Only account classes 5XXX, 6XXX, 7XXX, and 8XXX are included.
- The table is updated on an hourly basis (at the top of the hour).
- The following filters are available to view selected accounts and are highlighted with a corresponding color. Select the filter checkboxes as needed to narrow the display of accounts in the table.
  - >80 (green)
  - <=100 (yellow)
  - >100 (red)
  - Exception (purple)
- **Approval Summary** - (Business users) Displays a list of pending approval items based on your user's profile. If there are no approvals, a message is displayed indicating there are no pending approvals.

All ASCENDER users created in Security Administration are automatically granted permission to view all dashboard elements. However, the content within the dashboard element is driven by your user profile (**Profile Name**) in Security Administration with the exception of ASCENDER News, which is available to all users. The LEA News may be limited to certain users based on the LEA's preferences when adding the news entry in District Administration.

Each dashboard element tile is enabled with the drag-and-drop feature along with row x column layout options to allow you to customize the layout of your dashboard elements. Your selected layout preferences are automatically saved upon logging out of the software.

## Drag-and-Drop Feature

Use the drag-and-drop feature to define the placement of the dashboard element tiles.

- Press and hold down the left mouse button on the desired element tile to "Grab" it.
- "Drag" the element tile to the desired location.
- "Drop" the element tile by releasing the mouse button.

## Column x Row Layout Options

Use the following layout options located at the top of each dashboard element tile to adjust the size (column = width and row = height) of the element tile. To view these options, use your mouse to hover over the top-right corner of the element.

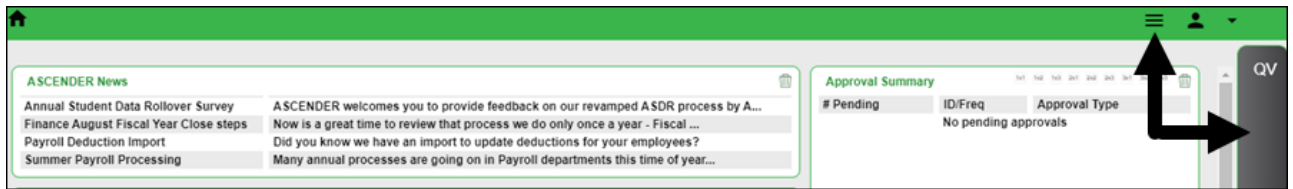
### Delete an element:

If you do not want an element displayed on your dashboard, you have the ability to move it out of view to the **Quick View** or **QV** column, which is the gray column located along the right side of the page.

- On any dashboard element, click to remove the element tile from the main dashboard view. The element is moved to the **Quick View**.
- By default, the **QV** column is collapsed. Click at the top of the page to expand the column and view the contents. Click again to collapse the **QV** column.

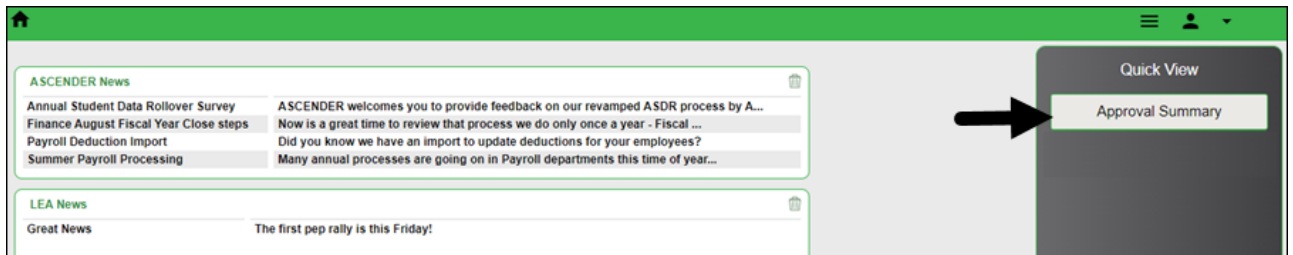
### Collapsed Quick View





## Expanded Quick View

Below is an example of the **Approval Summary** element tile being deleted from the main dashboard view and moved to the **Quick View**.



**Note:** At any point, you can use the drag-and-drop feature to move elements from the **Quick View** back to the main dashboard view.

## Approval Summary

All users are granted permission to the Approval Summary dashboard element, which provides a list of pending approval items based on the user's profile. If there are no approvals, a message is displayed indicating there are no pending approvals.

Click [here](#) for a complete list of approval types that are included in the Approval Summary (based on your user profile).

<b># Pending</b>	Displays the number of pending approval items for the corresponding approval type.
<b>ID/Freq</b>	Displays the ID or pay frequency tied to the pending item, if applicable.
<b>Approval Type</b>	Displays a link to the page where you have pending approval items.



In this example, the user has a pending approval for a CIP transaction.

☐ Click the link. The selected application page opens in a separate browser window.

- ☐ Perform the necessary action to satisfy the pending item(s).
- ☐ Log out of ASCENDER and then log back in to refresh the homepage.

If there are no other pending approvals, a message is displayed indicating there are no pending approvals.

## Approve Requisitions and Print PO's

### 1. [Approve a requisition.](#)

#### Approve a requisition

[Purchasing](#) > [Maintenance](#) > [Approve Requisition](#)

Only users who have permission to approve requisitions can access the Approve Requisitions page. This page allows approvers to:

- Approve or disapprove individual requisition items.
- Approve or disapprove the entire requisition.
- Return the requisitions and/or line items to the originator for additional editing.

If you are the final approver, the vendor and account codes must be completed before the requisition is approved.

If you want another individual to review the requisition before you review it, you can insert an approver prior to your name.

If you want another individual to approve the requisition after you, you can add an approver after your name. Click **Path** to add approvers to the approval path.

<b>Retrieve an existing record.</b>	<b>Requisition Nbr</b>	Type the six-digit requisition number to be retrieved, if known. Leading zeros are not required. However, if alphanumeric values are entered, the field is not zero-filled.
	Click <b>Retrieve</b> . If the requisition number is not known, click <a href="#">Directory</a> .	

The selected requisition is displayed. Review the requisition data and make changes as needed. Otherwise, use the following steps to approve, skip, or return a requisition.

**Note:** If **Reset Approval Path Purchasing** is selected on the [Finance > Tables > District Finance Options > Finance Options](#) page, any changes will cause the requisition to be returned to the originator for resubmission.

<b>Approve</b>	<p>Click to approve the requisition and forward the requisition to the next approver in the approval path.</p> <p><b>Note:</b> An error message is displayed when approving a requisition that contains a line item without an account code. The originator can submit a requisition without an account code, but a requisition cannot be approved without an account code. A message is displayed indicating that the approval is completed. Click <b>OK</b>. If the final approver approves the requisition, the requisition is converted to a purchase order and the following message is displayed.</p>
<b>Skip</b>	Click to continue to the next requisition without taking action on the currently displayed requisition.
<b>Return</b>	<p>Click to disapprove the complete requisition and return the requisition to the originator. If there are changes to the requisition, a pop-window with the requisition details is displayed prompting you to verify and continue. If there are no changes, a pop-window is displayed prompting you to continue.</p> <ul style="list-style-type: none"> <li>◦ Click <b>Yes</b> to continue. A message is displayed indicating that the requisition was returned. Click <b>OK</b>.</li> <li>◦ Click <b>No</b> to return to the Approve Requisition page without returning the requisition. The originator can edit the returned requisition and resubmit it.</li> </ul> <p>Click <b>Comments</b> to provide notes to the originator about the return reason. If there are changes to the requisition, a pop-window with the requisition details is displayed prompting you to verify and continue.</p> <p>Click <b>Yes</b> to continue. Otherwise, click <b>No</b>.</p>


This report provides an automated means of printing purchase orders to send to vendors.

- ☐ Click [PO Signature](#) to select a signature to be displayed on the purchase order.
- ☐ Click **Contract** to display contract formats. If purchase orders did not correctly print, use the [REQ1500 - Reprint Purchase Orders](#) page to reprint the purchase orders.

#### Notes:

- Even if you do not actually print the purchase order, you must click  to register the purchase order.
- The vendor name is not printed on the purchase order if a DBA name exists for the vendor on the [Finance > Maintenance > Vendor Information > Vendor Name/Address](#) tab.

## Receive purchase orders

This page is used to receive purchased goods/services. Use the packing slip to accurately update the receiving details.

Only requisitions for which you are the originator are displayed. Receiving is performed by the requisition number within the purchase order number. Purchase orders are displayed in the summary section, and associated requisitions are displayed in the detail section. Purchase orders created in the current accounting period can be received in the next accounting period.

If **Create Receiving Payables** is selected on the District Administration > Options > Purchasing/Warehouse page, payable transactions are automatically created on the [Finance](#) > [Maintenance](#) > [Pending Payables](#) page.

☐ Under **Retrieval Options**:

<b>Retrieve an existing record.</b>	<b>Purchase Order Nbr</b>	Type the purchase order number to be retrieved. If the PO number is numeric, leading zeros are not required.
	<b>Requisition Nbr</b>	Type the requisition number to be retrieved. If the requisition number is numeric, leading zeros are not required.
Click <b>Retrieve</b> . If the purchase order or requisition number is not known, click <a href="#">Directory</a> . <b>Notes:</b> The following receiving options selected on the <a href="#">District Administration &gt; Options &gt; Purchasing/Warehouse</a> page determine how information is displayed as well as if certain requisition items can be received on this page. If <b>Use Blind Receiving</b> is selected, order quantities are not shown on this page.  If <b>Allow Partial Receiving</b> is not selected, only complete requisition items can be received.  If <b>Allow Receiving Overage</b> is not selected, only the original item quantity ordered or less can be received.

☐ Complete the receiving details for the requisition:

<b>Date Received</b>	This field is automatically populated with the current date. You can edit the date to reflect the actual date that the items were received.
	<b>Note:</b> The date is no longer per line item.
<b>Quantity Received</b>	For each line item, type the number of items received.

**Note:** If a requisition contains line items generated by Finance when a purchase order is changed, payable check transactions can only be received, not created.

☐ Click **Receive All** to receive all items in the requisition.

☐ Click **Save** to update the requisition receiving details.
