## **Grade Reporting > Maintenance > Master Schedule > District Schedule**

☐ Modified the program to change a decimal point typed into the **Tot Credits** field to a zero when clicking **Save** (DBA Assistant was also updated to fix any pre-existing data with a decimal in it).

## **Registration > Maintenance > District Profile > District Information > District Maintenance > Control**

☐ Modified the **Do not create STAAR 2020 Waived Recds** functionality to only create 2020 waived records for students who previously failed the EOC exam in that subject but passed the course with full credit in the 2020 school year if the student graduated in the 2020 school year.

## **Attendance > Maintenance > Campus > Next Year Copy Calendar**

☐ Modified the program to no longer require you to press the ENTER key when adding a new track. Now, the new attendance track is automatically added to the grid after you click **+Add** and type the two-digit track. Previously, a browser error occurred upon pressing the ENTER key.

## **Registration > Maintenance > Online Registration > New Student Enrollment**

☐ Modified the program to correct the error of new student ID not automatically assigning when clicking **Save**.

## **Registration > Maintenance > Online Registration > Pending Updates**

☐ Corrected the pending update errors that occurred when trying to accept and save records.

## **Scheduling > Maintenance > Live Scheduling Load**

☐ Modified the Run Schedule Load functionality to reduce processing time and table locks.
