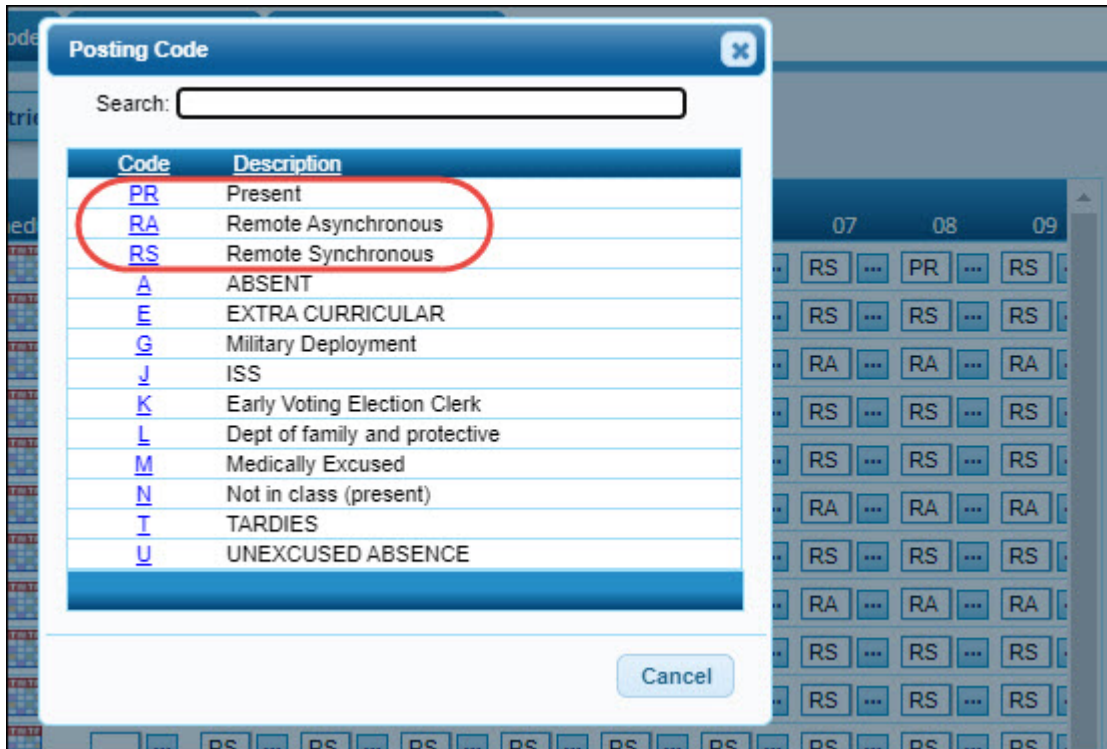
## Attendance > Maintenance > Student > Student Posting with Comments

Modified By Period, By Individual, By Date/Control Nbr, By Date/Grade and Code, By Date/Course, and By Generic Program to allow posting and viewing of either an absence or presence code for students.

Removed the *P* option to delete an absence (Present is now *PR*).

Added the following presence codes to the Posting Code ellipsis: Present (*PR*), Remote Synchronous (*RS*), and Remote Asynchronous (*RA*).

**NOTE:** When you replace any saved posting code with a Present (*PR*), that row in the posting table will be deleted and an audit row will be created for it.

Modified Attendance Audit to include the presence posting code.

## Attendance > Utilities > Import External Gradebook Absences

Removed the utility from the application.

Modified the program so that the following rows on the reports calculate properly (the same way as the same rows from the TEA TSDS PEIMS PDM3-130-001 report):

- **H1 Early Ed Eco Dis Elig Days**
- **H2 Early Ed Lang Elig Days**
- **H3 Early Ed Eco Dis & Lang Elig Days**

**Registration > Maintenance > District Profile > Move To Grade Reporting**

Corrected the issue not allowing users who ran Load from Backup to run Move to Grade Reporting. This affected users who had selected **Set To Campus Track** for at least one campus on the Campus Move Options tab and caused them to receive the following error message: "No First day of School Found."

Maintenance > Principal/Counselor  
Grade Reporting > Maintenance > Master Schedule > Campus Schedule > Instructor**

Corrected the program to display next year employees in the **Staff ID** ellipsis.

**Grade Reporting > Maintenance > Tables > Campus Control Options > Parameters**

Corrected the program validation to match cycle end dates to the Attendance calendar by campus/track.

**Grade Reporting > Maintenance > Student > Individual Maint > Assignments**

Corrected the program error that was caused by an assignment with a blank due date.

Grade Reporting > Maintenance > Gradebook Options > Campus >**

## Administrative Users

Modified the **User Name** field to allow up to 25 characters (the same as TeacherPortal).

## Test Scores > Utilities > Import Test Scores > AP Import

Modified the program to match up to 50 characters for students' first and last names.

Updated the following exam descriptions in the **Exam Code** drop down:

- 14: Changed from *Studio Art: Drawing Portfolio* to *Drawing*
- 15: Changed from *Studio Art: 2-D Design Portfolio* to *2-D Art and Design*
- 16: Changed from *Studio Art: 3-D Design Portfolio* to *3-D Art and Design*
- 96: Changed from *World History* to *World History: Modern*

## ParentPortal

Added the **Elementary Report Cards** button to allow parents to view elementary skills-based report cards.

Corrected the program to only display the **Sex** field once during the Registration process.

Corrected the program to only display fields as indicated on the ParentPortal > Admin > Form Creator page.

Modified the program to properly display fields in Spanish instead of English when Spanish is selected as the language.

## Admin > Form Management > Form Creator

Corrected the issue that caused a static form to be saved as a dynamic form when Spanish was selected as the language.

## Admin > Form Group Management > Returning Student Registration

Corrected the program to auto-populate the district name (e.g., Texas ISD) where applicable on the following forms:

- FERPA
- Food Allergy Disclosure
- Student Health Information Sheet

## Summary > Registration

Corrected an issue where a form for Online Registration was not displaying, but the parent/guardian could save the form and continue.

## Login

Corrected the issue that prevented some users from recovering their user name or resetting their password. These users received the following error message: "One or more of the following fields failed to match a user record or the user record is not active."

Corrected the issue that prevented some users from creating an account.

## Attendance > Post/View Attendance

Corrected the program to display the **Activate** / **Inactive** options under **Attendance** for students who were inactivated by the LEA for First Day Counts.

## Grades > Assignment Grades

- Corrected the Transfer Student pop-up window to properly display the **From** details.
- Modified the program to correctly retrieve assignments by **Due Date** when either manually entering a date or selecting a date from the calendar. Also, corrected the program error that may have occurred when manually entering a due date and tabbing out of the field.

### **Reports > Cycle Grade Range**

- Corrected the program to allow a maximum grade of 100. Previously, an error occurred.

### **Reports > Rubrics**

- Corrected the report to bold the **Points Earned** value in the **Student Score** column and add a page break between students when printing the report.

### **Admin > Elementary Report Cards > Manage Elementary Skills-Based Courses**

- (*Released on 08/28/2020*) Modified the program to properly allow the use of Elementary Skills-Based courses.

### **Settings > Manage Course Groups**

- Corrected the program to match the instructor's schedule.

### **Settings > Manage Course Groups**

- Corrected the functionality of the **Recheck Validity** button.
