<b>Secondary Disability</b>	<p>The student's secondary disability is displayed. This code is not required unless the student has been identified with a secondary disability code by the ARD committee.</p> <p>TWEDS Data Element: Disability (E3015) (Code Table: C053)</p> <p>This field is maintained on <a href="#">Registration &gt; Maintenance &gt; Student Enrollment &gt; SpecEd</a></p>
<b>Tertiary Disability</b>	<p>Select the student's tertiary disability.</p> <p>TWEDS Data Element: Disability (E3015) (Code Table: C053) indicates the disability category that describes a child's impairment.</p> <p>This field is maintained on <a href="#">Registration &gt; Maintenance &gt; Student Enrollment &gt; SpecEd</a></p>
<b>Multi Disability</b>	<p>The field is selected if the student is multiply disabled.</p> <p>TWEDS Data Element: MultiplyDisabled (E0882)</p> <p>This field is maintained on <a href="#">Registration &gt; Maintenance &gt; Student Enrollment &gt; SpecEd</a></p>
<b>Child Count Funding Code</b>	<p>The federal program under which the student is funded is displayed.  <b>NOTE:</b> This field is automatically set to 3 (<i>Individuals With Disabilities Education Act (IDEA) Amendments of 2004</i>) when a student is enrolled in special education from the Registration application.</p> <p>TWEDS Data Element: ChildCountFunding (E0832) (Code Table: C066)</p> <p>This field is maintained on <a href="#">Registration &gt; Maintenance &gt; Student Enrollment &gt; SpecEd</a></p>
<b>IEP Continuer</b>	<p>Select if the student is at least 18 years old as of September 1 and has satisfied the credit requirements for high school graduation, but has not completed his individualized education program (IEP), and is enrolled and receiving IEP services.</p> <p>TWEDS Data Element: StudentCharacteristic (E1564) (Code Table: C088)</p>
<b>Early Childhood Intervention</b>	<p>The field is selected if the student participates in the Early Childhood Intervention (ECI) program.</p> <p>TWEDS Data Element: SPEDProgramSvc (E0900) (Code Table: C341)</p> <p>This field is maintained on <a href="#">Registration &gt; Maintenance &gt; Student Enrollment &gt; SpecEd</a></p>

<b>Preschool Program (PPCD)</b>	<p>Select if the student is enrolled in the Preschool Program for Children with Disabilities (PPCD). <b>Mental Retardation Code</b>			
<b>Adaptive PE</b>	Select if the student participates in a physical education program adapted for students with special needs.		
<b>Weekly Spec ED Instruction Time</b>	Select the amount of time a special ed instructor works with the student.		
<b>Vocational Education</b>	Select the vocational program in which the student participates.		
<b>IEP Services Initiated</b>	Type the first date on which the student was provided services specified in the initial IEP. Use the MMDDYYYY format. Or, click  to select the date from a calendar.		
<b>FIE Report Date</b>	Type the date on which the student's most recent Full and Individual Evaluation (FIE) comprehensive assessment was performed. Use the MMDDYYYY format. Or, click  to select the date from a calendar.		
<b>Print Profile</b>	<p>Select if you want to allow printing of the student's special ed profile when running <a href="#">Reports &gt; Special Ed &gt; Student &gt; SEM0350 - Special Ed Student Profiles</a>.</p> <p>This field is automatically selected after ASDR is run.</p>		
<b>Non-Public School Name</b>	Type the name of the non-public school, institution, or hospital where the student is receiving special ed services. This applies only to students on contract with a non-public school.		
<b>Medicaid Eligible</b>	<p>Select if the student is eligible to receive Medicaid services.</p> <p>The field can also be updated on <a href="#">Registration &gt; Maintenance &gt; Student Enrollment &gt; Demo2</a>.</p>		
<b>TX Medicaid ID</b>	Type the student's nine-digit Medicaid ID. This is required to request Medicaid reimbursement from the School Health and Related Services (SHARS) for certain health related services provided to special ed students.
