Registration > Maintenance > Student Enrollment > Bil/ESL

This tab allows you to view and update information for students who participate in a bilingual or English as a second language (ESL) program.

- Emergent Bilingual (EB) students must be identified as EB, and a parental permission code is required.
- Students who are not EB can be enrolled in a bilingual or ESL program, and the parental permission code must reflect that the placement is for a non-EB student.

The Bil/ESL tab is not available until you retrieve a student on the [Student Enrollment](#) page. For a new student, you must enter and save all required data on [Demo1](#) before proceeding to this tab.

Funding:


- Non-EB students are not eligible for funding.
- A bilingual or ESL student who is placed in a disciplinary setting, and ESL/BIL services are not provided during that time, is not eligible for funding.
- Other students may also not be eligible for funding. See the Student Attendance Accounting Handbook, Section 6 - Bilingual/English as a Second Language (ESL) for more information.












The student's existing bilingual/ESL entry/withdrawal/reentry records are displayed. If the most recent row contains an exit date and withdrawal reason code, you can add a record.

<p>Home Lang</p>	<p>If the student's home language has changed, click  to select the primary language spoken by the student. NOTE: Once you accept the student's Home Language Survey, this field is updated according to the parent's answer to the question What language is spoken in the child's home most of the time? TWEDS Data Element: HOME-LANGUAGE-CODE (E0895) (Code table: C092)</p>

Student Language	<p>Click  to select the primary language spoken by the student.</p> <p>NOTE: By default, this field is set to default to value established in Default Home Language Cd on Maintenance > District Profile > District Maintenance > Control Info when a new student is added.</p> <p>Once you accept the student's Home Language Survey, this field is updated according to the parent's answer to the question What language does the child speak most of the time?</p> <p>A student cannot be EB if his Home Lang and Student Language are both English (98).</p> <p>TWEDS Data Element: STUDENT-LANGUAGE-CODE (E1590) (Code table: C092)</p>
Yrs US Sch	<p>If the number of years the student has been enrolled in U.S. schools has changed, select the number of years. This field is automatically incremented during Move to Grade Reporting.</p>
Date HLS Admin	<p>Enter the date on which the <i>Home Language Survey</i> form was administered. Use the MMDDYYYY format. Or, click  to select the date from a calendar.</p> <p>This field can only be saved when both the Home Language and Student Language fields have values.</p> <p>You cannot enter a future date.</p>
Campus	<p>The campus ID to which you logged on is displayed.</p>
Entry Date	<p>To enroll a student in the program, type the date the student entered the program. Use the MMDDYYYY format. Or, click  to select the date from a calendar.</p> <p>If there are existing entry/withdrawal records for the student, the entry date for the new record must be after the last exit date.</p> <p>The student can have only one active record (i.e., a record without an exit date).</p> <p>The entry/exit dates for different records cannot overlap.</p>
Exit Date	<p>To withdraw a student from the program, type the date the student exited from the program. Use the MMDDYYYY format. Or, click  to select the date from a calendar.</p> <p>The exit date should be the school day following the last day the student was in the program.</p>

Changes to the following fields usually occur when there is a status change (withdrawal reason code 33). The new information is entered upon reentry.

<p>Bilingual</p>	<p>If the student's participation in the bilingual program has changed, indicate if the student is participating in a state-approved bilingual education program. If the student is in an ESL program, leave this field blank.</p> <p>TWEDS Data Element: BILINGUAL-PROGRAM-TYPE-CODE (E1042) (Code table C175)</p>
<p>ESL</p>	<p>If the student's participation in the ESL program has changed, indicate if the student is participating in a state-approved ESL education program. If the student is in a bilingual program, leave this field blank.</p> <p>TWEDS Data Element: ESL-PROGRAM-TYPE-CODE (E1043) (Code table C176)</p>

EB Cd	<p>Select the code that applies to the student's emergent bilingual status as indicated by the Language Proficiency Assessment Committee (LPAC). Or, if the year in which the student is being monitored for EB has changed, select the code indicating the monitoring year.</p> <p>If the student is EB, an EB monitoring code cannot be selected.</p> <p>If the student has a row with the withdrawal reason code set to EP (<i>exit the bilingual or ESL program</i>), Annual Student Data Rollover (ASDR) will set EB Cd to F (<i>exited from EB - Monitored 1 (M1)</i>).</p> <p>If EB Cd is F, ASDR will increment the code to S (<i>exited from EB - Monitored 2 (M2)</i>).</p> <p>If EB Cd is S, ASDR will create a third year EB monitoring record in the new school year (EB Ind = 3).</p> <p>If EB Cd is 3, ASDR will create a fourth year EB Monitoring record in the new school year (EB Ind = 4).</p> <p>If EB Cd is 4, ASDR will create an EB code 5 record (<i>former EB/EL student</i>) in the new school year.</p> <p>If EB Cd is 5, ASDR will create an EB code 5 record in the new school year.</p>						
Par Perm Cd	If the student's parental permission has changed, indicate if the student's parent or guardian has granted permission to place the student in the bilingual or ESL program.						
Bil/ESL Fund Cd	Select the language program in which the student participates during the reporting period that generates funding under TEC 48.105.						
Alt Lang Cd	<p>Indicate the type of alternative language program participated in by the student. An alternative language program must be approved by the TEA due to the LEA submission of a bilingual education exception and/or English as a second language (ESL) waiver for the current school year.</p> <p>TWES Data Element: ALTERNATIVE-LANGUAGE-PROGRAM-CODE (E1642) (Code table: C221)</p>

	<p>Edit a record. The data is displayed in fields below the grid allowing you to make changes.</p> <p>Update the fields as needed, click OK, and then click Save. The changes are displayed in the grid.</p>
	<p>Delete a row.</p> <p>1. Click  to delete a row. The row is shaded red to indicate that it will be deleted when the record is saved. You can select multiple rows to be deleted at the same time.</p> <p>2. Click Save. You are prompted to confirm that you want to delete the row. Click Yes to continue. Otherwise, click No.</p> <p>You can save edits and delete records in the same step (i.e., the changes are all committed when the record is saved).</p>
Comments	<p>View or add comments. Click to view or add comments about the student. The Comments window opens.</p> <p>If comments exist for the student, an exclamation mark is displayed on the button and it is outlined in red.</p>
Hist Directory	<p>Retrieve a student enrolled in a prior school year.</p>
Bus Info	<p>View or update the student's bus information. The button does not appear until you retrieve a student on the Student Enrollment page.</p>
	<p>View medical alert. The button is displayed if a medical warning exists for the student and Consent to Display Alert is selected on Health > Maintenance > Student Health > Emergency.</p> <p>Click to view the student's medical alert information.</p>
Documents	<p>View or attach supporting documentation.</p>
