# Bilingual/ESL

## Registration > Maintenance > Student Enrollment > Bil/ESL

This tab allows you to view and update information for students who participate in a bilingual or English as a second language (ESL) program.

- Emergent Bilingual (EB) students must be identified as EB, and a parental permission code is required.
- Students who are not EB can be enrolled in a bilingual or ESL program, and the parental permission code must reflect that the placement is for a non-EB student.

The Bil/ESL tab is not available until you retrieve a student on the [Student Enrollment](#) page. For a new student, you must enter and save all required data on [Demo1](#) before proceeding to this tab.

### Funding:

- Non-EB students are not eligible for funding.
- A bilingual or ESL student who is placed in a disciplinary setting, and ESL/BIL services are not provided during that time, is not eligible for funding.
- Other students may also not be eligible for funding. See the Student Attendance Accounting Handbook, Section 6 - Bilingual/English as a Second Language (ESL) for more information.




















### Update data:

The student's existing bilingual/ESL entry/withdrawal/reentry records are displayed. If the most recent row contains an exit date and withdrawal reason code, you can add a record.

| <b>Exit Date</b>      | <p>To withdraw a student from the program, type the date the student exited from the program. Use the MMDDYYYY format. Changes to the following fields usually occur when there is a status change (withdrawal reason code 33). The new information is entered upon reentry.

| <b>ESL</b>             | <p>If the student's participation in the ESL program has changed, indicate if the student is participating in a state-approved ESL education program. If the student is in a bilingual program, leave this field blank.</p> <p>TWEDS Data Element: ESL-PROGRAM-TYPE-CODE (E1043) (Code table C176)</p>   |
| <b>EB Cd</b>           | <p>Select the code that applies to the student's emergent bilingual status as indicated by the Language Proficiency Assessment Committee (LPAC). Or, if the year in which the student is being monitored for EB has changed, select the code indicating the monitoring year.</p> <p>If the student is EB, an EB monitoring code cannot be selected.</p> <p>If the student has a row with the withdrawal reason code set to EP (<i>exit the bilingual or ESL program</i>), Annual Student Data Rollover (ASDR) will set <b>EB Cd</b> to F (<i>exited from EB - Monitored 1 (M1)</i>).</p> <p>If <b>EB Cd</b> is F, ASDR will increment the code to S (<i>exited from EB - Monitored 2 (M2)</i>).</p> <p>If <b>EB Cd</b> is S, ASDR will create a third year EB monitoring record in the new school year (<b>EB Ind</b> = 3).</p> <p>If <b>EB Cd</b> is 3, ASDR will create a fourth year EB Monitoring record in the new school year (<b>EB Ind</b> = 4).</p> <p>If <b>EB Cd</b> is 4, ASDR will create an EB code 5 record (<i>former EB/EL student</i>) in the new school year.</p> <p>If <b>EB Cd</b> is 5, ASDR will create an EB code 5 record in the new school year.</p> |
| <b>Par Perm Cd</b>     | <p>If the student's parental permission has changed, indicate if the student's parent or guardian has granted permission to place the student in the bilingual or ESL program.</p>   |
| <b>Bil/ESL Fund Cd</b> | <p>Select the language program in which the student participates during the reporting period that generates funding under TEC 48.105.</p>  |
| <b>Alt Lang Cd</b>     | <p>Indicate the type of alternative language program participated in by the student. An alternative language program must be approved by the TEA due to the LEA submission of a bilingual education exception and/or English as a second language (ESL) waiver for the current school year.</p> <p>TWES Data Element: ALTERNATIVE-LANGUAGE-PROGRAM-CODE (E1642) (Code table: C221)</p>   |



|  | <p><a href="#">Delete a row.</a></p> <p>1. Click  to delete a row. The row is shaded red to indicate that it will be deleted when the record is saved. You can select multiple rows to be deleted at the same time.</p> <p>2. Click <b>Save</b>. You are prompted to confirm that you want to delete the row. Click <b>Yes</b> to continue. Otherwise, click <b>No</b>.</p> <p>You can save edits and delete records in the same step (i.e., the changes are all committed when the record is saved).</p> |
| <b>Comments</b>   | <p><a href="#">View or add comments.</a></p> <p>Click to view or add comments about the student. The Comments window opens.</p> <p>If comments exist for the student, an exclamation mark is displayed on the button and it is outlined in red.</p>  |
| <b>TEA Unique ID</b>  | <p><a href="#">Request an Unique ID from the state.</a></p> <p>Click on the TEA Unique ID button to request an Unique ID from the state for students and staff.</p>  |
| <b>Hist Directory</b>   | <p><a href="#">Retrieve a student enrolled in a prior school year.</a></p>   |
|  | <p><a href="#">View medical alert.</a></p> <p>The button is displayed if a medical warning exists for the student and <b>Consent to Display Alert</b> is selected on <a href="#">Health &gt; Maintenance &gt; Student Health &gt; Emergency</a>.</p> <p>Click to view the student's medical alert information.</p>   |
