Notes:

- The **Offset Obj**, **Offset Subj**, and **Offset Org** fields can only be changed for an unprinted invoice.
- By default, the **Offset Obj** and **Offset Subj** fields are automatically populated based on the **Accounts Receivable** field on the Finance > Tables > District Finance Options > Clearing Fund Maintenance tab.
- By default, the **Offset Org** field is set to 000.
- The **Offset Obj** field is limited to 12XX accounts only.
- The **Offset Fund** and **Offset Fscf Yr** fields cannot be changed.
