The following elements from the *StaffExtension* complex type are included in Submission 1:

- ☐ FIRST-NAME **Name - Legal - First** (E0703) is the person's legal first name which must match the first name as shown on the identification documentation (social security card).
 - ☐ MIDDLE-NAME **Name - Legal - Middle** (E0704) is a person's legal middle name which must match the middle name as shown on the identification documentation (social security card). If, and only if, the person has no middle name, the field must be left blank. Do not use any other text such as NONE or NA. Do not use punctuation other than a hyphen, space, or single apostrophe.
 - ☐ LAST-NAME (E0705) **Name - Legal - Last** is a person's legal last name which must match the last name as shown on the identification documentation (social security card).
 - ☐ GENERATION-CODE **Name - Legal - Generation** (E0706) is the generation suffix, if any, which the person attaches to his name. If the person has no generation code, the field must be left blank.
 - ☐ SEX-CODE **Sex** (E0004) is the person's gender.
 - ☐ DATE-OF-BIRTH **DOB** (E0006) is the month, day, and year of the person's birth.
 - ☐ HISPANIC-LATINO-CODE **Ethnicity - Hispanic/Latino** (E1064) indicates a person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race.
 - ☐ AMERICAN-INDIAN-ALASKA-NATIVE-CODE **Race - American Indian Alaskan Native** (E1059) indicates a person having origins in any of the original peoples of North and South America (including Central America).
 - ☐ ASIAN-CODE **Race - Asian** (E1060) indicates a person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.
 - ☐ BLACK-AFRICAN-AMERICAN-CODE **Race - Black African American** (E1061) indicates a person having origins in any of the black racial groups of Africa.
 - ☐ NATIVE-HAWAIIAN-PACIFIC-ISLANDER-CODE **Race - Native Hawaiian Pacific Islander** (E1062) indicates a person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.
 - ☐ WHITE-CODE **Race - White** (E1063) indicates a person having origins in any of the original peoples of Europe, the Middle East, or North Africa.
