Update data for the *TeacherSectionAssociationExtension* complex type as needed.

The *TeacherSectionAssociationExtension* complex represents a person employed by the LEA or other educational unit engaged in student instruction. These are instructional-type staff members.

### Modify a record:

#### Select a student

To retrieve a student's records, select the student in one of the following ways:

| Stu ID                    | Begin typing the student ID. As you begin typing the student ID, a drop-down list<br>displays students whose ID matches the numbers you have typed. The drop-down list<br>displays the students' full name and grade level. From the drop-down list you can<br>select the student.   |  |

| Directory                 | Click <b>Directory</b> to select a student from the directory.   |  |

| Class ID              | CLASS-ID-NUMBER (E1056)  |  |  |

|                       | Type the 14-digit number identifying the class. | Course<br>Sequence    | COURSE-SEQUENCE-CODE (E0948)<br>Code table: C135   |  |  |
|                       | This is the order in which the course was scheduled. This should only be used if the course, or part of the course, is taught out of sequence. Leave blank if the course is not taught out of sequence.  |  |  |
|                       | Rule 43415-0036: If a student passed a course where <b>Dual Credit</b> is selected and <b>Course Sequence</b> is 0, 2, 5, or 9, then <b>College Credit Hrs</b> must be greater than 0.   |  |  |
| Pass/Fail             | PASS/FAIL-CREDIT-INDICATOR-CODE (E0949)<br>Code table: C136  |  |  |
|                       | Select the student's outcome for the course. You must enter a pass/fail indicator for each service ID reported.  |  |  |

| Dual Credit           | DUAL-CREDIT-INDICATOR-CODE (E1011)<br>Code table: C088   |  |  |
|                       | Select if the student is eligible to receive both high school and college credit for the course. You can select <b>Dual Credit</b> or <b>ATC</b> , but not both.   |  |  |
|                       | Rule 43415-0036: If a student passed a course where <b>Dual Credit</b> is selected and <b>Course Sequence</b> is 0, 2, 5, or 9, then <b>College Credit Hrs</b> must be greater than 0.   |  |  |
| College<br>Credit Hrs | COLLEGE-CREDIT-HOURS (E1081)   |  |  |
|                       | This is the number of college hours the student earned for the completion of the dual-credit course. If a student takes a dual-credit course and does not complete the course, type 0.   |  |  |

|                       | For Submission 4, the field must be 0 (i.e., not selected).  |  |  |

| Course<br>Completion | COURSE-COMPLETION-INDICATOR (E1068)<br>This indicates if the student finished the full sequence of instruction for the course,<br>but does not necessarily indicate that the student met all requirements to receive<br>credit or a grade for the course.<br>The PASS/FAIL-CREDIT-INDICATOR-CODE field is used for COURSE-COMPLETION-<br>INDICATOR.  |
|----------------------|--|
|                      | All students must have a Pass/Fail indicator to create the course completion record.   |
| Begin Date           | STUDENT-BEGIN-DATE (E1069)<br>Type the beginning date for the student's current year class assignment. Use the<br>MMDDYYYY format. This is the date the dual-credit course began. If a student is<br>assigned to a class, withdraws from that class, and then returns to that class at a<br>later date, there must be a record for each begin date.  |
| End Date             | STUDENT-END-DATE (E1070)<br>Type the ending date for the student's current year class assignment. Use the<br>MMDDYYYY format. This is the date the dual-credit course ended. If a student<br>withdraws from a class, returns to that class, and then withdraws from class at a<br>later date, there must be a course completion record for each of these STUDENT-<br>END-DATEs. Whether or not a student completes a particular course section, report<br>the STUDENT-END-DATE as the last day the student was assigned to the class. The<br>STUDENT-END-DATE should never be greater than a student's withdrawal date from<br>the campus. |

| Add | Add a student.<br>Click to add a student who does not already exist in ASCENDER State Reporting tables.<br>Manual entry of a student is rare and generally only needed when a district is using ASCENDER<br>State Reporting only. Most districts extract the data from ASCENDER. | Change ID        | Change the student's ID.<br>The <b>Change ID</b> button is disabled until a student is retrieved on the page.   |
|                  | Retrieve a student, and click <b>Change ID</b> . The <b>Change Student ID</b> section is displayed at the top of the page.                                  |
|                  | In the <b>New Student ID</b> field, type a valid social security number that you would like to change the existing ID to, and then click <b>Submit</b> .    |
|                  | The <b>Change Student ID</b> dialog box is displayed prompting you to review the change ID request information and accept the information if it is correct. |
|                  | Click <b>OK</b> to continue. Otherwise, click <b>Cancel</b> .   |
| Prev and<br>Next | Scroll through students.<br>Once a student is retrieved, click <b>Prev</b> or <b>Next</b> to scroll to the previous or next student<br>alphabetically.      |
